NOTICE OF ANNUAL GENERAL MEETING AND CONFERENCE

Dear Members and Provincial Organisations

The National Council has directed me to inform and invite you take part at the Canadian Hellenic Congress (CHC) November 2023 annual National Convention which will be held on Sunday, November 26, 2023.

Both the Annual General Meeting and the Conference will be conducted via electronic means. The Annual General Meeting (AGM) will be held in the morning of Sunday, November 26, 2023, and the Conference in the afternoon. The AGM will start at 11:00 a.m. and end at 1:00 p.m. The AGM Notice and Agenda is attached to these communications as **Appendix A.**

The afternoon session of the Convention, will be the conference entitled "Chamuria and the 'Tsamiko' Question: The Tale of the Execution of the 49 Procritus by the Chams and its aim" with retired Lieutenant General Ioannis Baltzois as keynote speaker, from 2:00 p.m. to 4:00 p.m.

Only regular paid-up members are entitled to have delegates to the Convention. Members whose membership has expired must pay their current membership fees and any outstanding arrears no later than **November 15**, 2023.

Former members, including provincial organisations, who have lost their membership status due to non-participation and non-payment of their membership fees for a period of at least three (3) years are not recognised nor have any rights to be engaged in the business of the AGM and must apply to be reinstated and acquire membership rights.

Any former member, including a provincial organisation, who wishes to be reinstated to full membership status, must apply to the National Council on or before **November 15**, **2023**.

The application, which could be in a form of a letter, addressed to the Secretary of the CHC, must:

- be accompanied by a **certified Board Resolution** signed by all the directors of the Former Member, in which is stated that it freely desires to rejoin the CHC, the Former Member recognises and acknowledges that the CHC as the national Canadian Hellenic institution and accepts, recognises and adheres to the Constitution of 2016, as amended, as the principal governing document, and accepts and recognises the current officers and directors as constituted following the 2022 National Council elections.
- The former Member must pay the current and all past membership dues to the CHC, as well as,
- Comply with the membership requirements as set out in Article 9 of the Constitution. (https://chenews.org/docs/chebylaws2016.pdf)

In accordance with the **CHC Reinstatement Membership Policy**, the National Council is authorised to review and decide on the former member's application for reinstatement.

Non-members can participate at the Convention without a right to vote and may speak at the AGM with the consent of the registered delegates.

The Governance Committee has initiated a review of the current By-laws. The CHC By-laws stipulate that only Members who have paid their membership fees in full are in good standing and are entitled to have delegate representation to the Annual General Meeting.

Members, including provincial organisations, who have not paid their current and past membership dues, must do so immediately and in any event must communicate with the Secretary and arrange for payment of dues. This must be done by no later than **November 15, 2023**.

There will be a registration fee of \$20.00 for each delegate participating via electronic means and voting. For the non-delegates, the registration fee will be \$25.00.

Members, either on their own or through their provincial organisations, are required to select their delegates and/or alternates and submit their names, by completing the Delegate Registration Form, plus registrations fees to the Secretary no later than **November 15, 2023.** Delegate Registration Forms are set out in **Appendix B**, attached to this Notice and Agenda.

The number of delegates each province is entitled to have at the Annual General Meeting is set out in **Schedule A**, attached to this Notice and Agenda.
